Take off charge

Take off charge is based on the authorized MTOW in the aircraft's certificate of airworthiness or noise certificate rounded to the nearest 1 000 kg.

Charge rate:

SEK 35 per 1 000 kilograms or parts thereof.

Minimum charge is SEK 400.

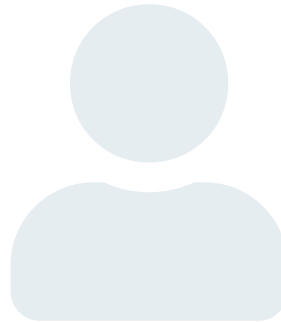


Passenger charge

Passenger charges are payable for all passengers to national and international destinations except children under the age of 2.

Charge rate:

SEK 88 per departing passenger.



Parking charge

No charge between 0–2 hours. Parking of aircraft is charged per 1 000/kg MTOW or part thereof. Minimum charge is SEK 250 per 24 hours.

Charge rate:

SEK 25 per 1 000 kg and 24 hours.



Ground handling and other services



Ramp service fee includes parking assistance, parking (0–2 hours) and electricity (30 minutes), loading and unloading of the aircraft. The fee is charged for each turnaround. Staircase, tractor, baggage transport and conveyor are included.

The fee is calculated from the number of seats in the aircraft

the extra opening hours are not in direct connection to
standard opening hours.

Environment

Environmental issues are of great importance to Karlstad Airport and our business plays an active role in creating a long-term sustainable society and we are constantly developing and improving our environmental work. It is important that all employees have an understanding and knowledge of the company's environmental work to enable set goals.

Karlstad Airport is environmentally certified according to ISO 14001. Through our environmental management systems we strive to minimize the environmental impact of our operations and we are constantly working to reduce our emissions.

Payment obligations

The aircraft owner, user and/or person acting as the representative of the owner of the aircraft are jointly and severally liable for the payment of the charges in this price list.

All rates are in SEK and are exclusive of any taxes or levies payable thereon. The total amount shall be rounded off to the next full SEK. Value added tax shall be paid according to the applicable law.

All charges prescribed according to this price list are due for immediate payment to Karlstad Airport. Unless otherwise agreed in writing, the owner, pilot or representative of the aircraft shall report to the Airport Office immediately before take off or immediately after landing at the airport.

Invoicing is the standard form of payment at Karlstad Airport. Agreement can be made concerning periodic invoicing, provided the owner or user of an aircraft operates on a regular basis or has higher volumes of traffic. Payment terms may not exceed 30 days.

Upon request, the airline is obliged to make all necessary information available to Karlstad Airport for credit rating purposes. All information received will be treated confidentially.

If Karlstad Airport considers the outcome of such credit rating to be unsatisfactory, the airport may request a first class on demand bank guarantee for a suitable amount from the airline on order to grant the airline periodic settlement of account.

In the event of payment failure, the following provisions shall apply:

- For overdue payment the interest charge is reference rate +8 %.
- In the event of failure to pay, Karlstad Airport may inform the airline that it will not be allowed to operate from Karlstad Airport until all charges plus interest and service fees have been paid in full
- In the event of failure to pay, Karlstad Airport is entitled by law to take legal action against the aircraft including but not limited to attachment of the aircraft itself, its fuel and engines irrespective of who may be from time to time the owner of such assets and Karlstad Airport will, without incurring any liability from the owner of the aircraft, the holder and user thereof and any person action as the representative of the owner, the holder or user thereof be entitled to prevent the aircraft from departing from Karlstad Airport until all charges have been paid in full
- Immediately after failure to pay, Karlstad Airport may demand a Banker's guarantee for the amount due and for expected charges for the following three months
- After failure to pay Karlstad Airport may change its agreed payment terms concerning periodic invoicing and revert to immediate payments for future take offs from the airport

Changes to the price list

Other

Karlstad Airport is not liable for any theft or damage caused by fire, water or any other cause with respect to the aircraft, its equipment, crew, passengers, cargo etc during the aircrafts stay at Karlstad Airport inside as well as outside.

Karlstad Airport has the authority to determine charges for special services at the airport. Charges not listed in this pricelist are quoted by Airport on request.

Any disputes arising out of or related to these charges regulations including the interpretation, validity and payment of charges due, shall be governed by Swedish Law and brought before the Courts of Sweden, with the district court of Karlstad being the court of first instance.

The English language version of these charges and regulations shall be the governing text.
